**INDIANA LAW ENFORCEMENT ACCREDITATION** is a process where law enforcement agencies can demonstrate voluntarily that they comply with state and national standards, which are an indication of professional excellence.

The **INDIANA LAW ENFORCEMENT ACCREDITATION COMMISSION**, organized in 2005 under the Indiana Association of Chiefs of Police in cooperation with the Indiana Sheriff's Association, has established a set of standards within which Indiana law enforcement agencies will be able to demonstrate their commitment to providing a standard of excellence dedicating and delivering services to the citizens of their respective jurisdictions, therefore advancing the professionalism of all law enforcement. Once an agency has decided to seek accreditation from ILEAC, it is vital to identify an individual to head the effort – the Accreditation Manager.

The **ACCREDITATION MANAGER** should report directly to the CEO or Deputy CEO. The person in this position will be responsible for performing administrative work with a minimal degree of supervision, coordinating accreditation activities assigned by the CEO, and making independent judgments and decisions based on analytical and innovative thinking. Minimum Qualifications: five (5) years continuous experience with a law enforcement agency; rank of lieutenant or above (preferable). Civilians filling this position should have the authority to make appropriate assignments throughout the agency and to enforce deadlines.
